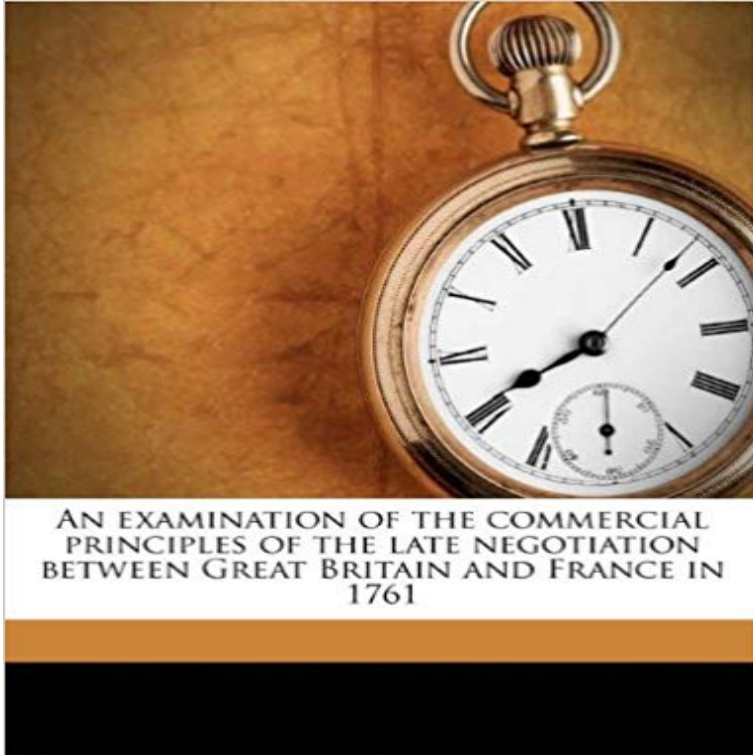


# An examination of the commercial principles of the late negotiation between Great Britain and France in 1761
