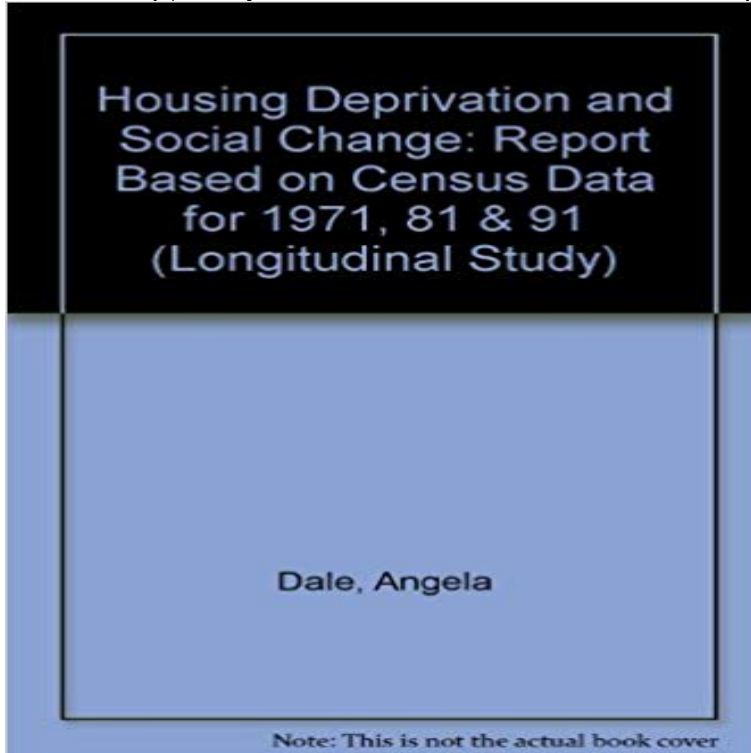


Housing Deprivation and Social Change (Longitudinal Study)
