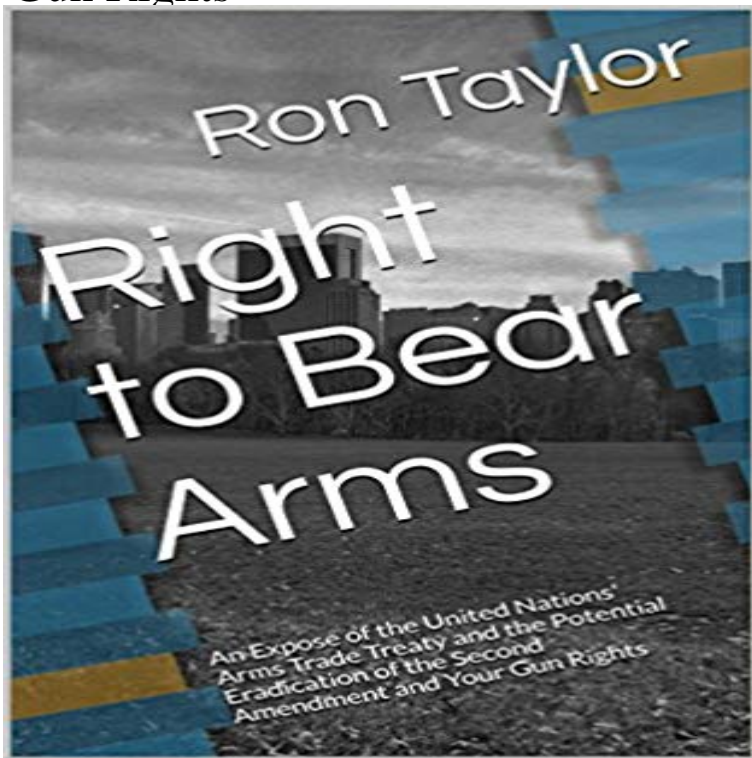


Right to Bear Arms: An Expose of the United Nations Arms Trade Treaty and the Potential Eradication of the Second Amendment and Your Gun Rights



Short of a Constitutional Amendment to repeal the Second Amendment, and further imposition of onerous regulations to limit access to civilian firearms and ammunition, gun control advocates know the surest route to eliminating legal firearms possession in the United States and ending your right to bear arms is to present their progressive ideologies to the United Nations. As a Signatory to the United Nations Charter, the United States is theoretically bound to adhere to treaties invoked by the United Nations. It remains to be seen if the government of the United States will enforce United Nations control of the international arms trade, but given the propensities of liberal policy within the United States, the forfeiture of your gun rights may be closer to reality than you think. At the heart of negotiations around the arms treaty is the concept known as global governance. Since President Woodrow Wilson fired the first shot for global governance with his League of Nations initiative following World War I (Wertheim, 2011), global elites have been enamored with the idea of controlling the worlds population and eliminating nationalism through a unified, international body. In one of his final public speeches in 1919, Wilson discussed the terms of the Paris Peace Treaty that ended World War I, and outlined his concept of a unified world government. According to Wilson, the terms of the treaty were designed to see that every government dealt with in this great settlement is put in the hands of the people and taken out of the hands of coteries and of sovereigns who had no right to rule over the people. Wilson went on to explain that the new League of Nations will have veto power over any nations desire to wage war against his enemy. In an ideal world this sounds wonderful. But in reality, the placement of national grievances before a unified body of diplomats assures that each nation will find

itself subject to the will of the majority. In Americas case, the current make-up of the United Nations General Assembly virtually guarantees any decision will be contrary to the national interests of America. Our grandfathers saw through Wilsons idyllic view of the world, but sadly, our fathers did not. Wilsons concept of a League of Nations never gained a foothold in the American political arena until the end of World War II, when his dream became a reality with the formation of the United Nations in 1945. The basic charter of the United Nations strives to shape the world by governing international trade, security, economic development, and social progress. But you need only look to its failure to feed starving people in Africa, or trade oil for food in Iraq, as examples of its weakness in global governance. Yet, these limitations do not stop the elite from transforming their so-called global values into international law. And while defenders of the United Nations charter point to the Security Council and our right to veto resolutions relevant to the Council, the remaining seven, non-permanent members of the Council, have the ability to block initiatives we may find strategically important through a majority vote. In a sense, the inherent limitations to global governance via a central body of diplomats should be a rallying cry for freedom loving individuals in America. But sadly, our own government appears anxious to facilitate the United Nations efforts to circumvent our Constitution, and to level the international playing field by reducing America to a second class world power. Interestingly, the former leader of the Soviet Union, Nikita Khrushchev, once stated, The purpose of the United Nations should be to protect the essential sovereignty of nations, large and small. Sure, he was most likely complaining about American attempts to slow the spread of communism, but even the First Secretary of the Soviet Union understood that national sovereignty trumps the new world order of global governa
