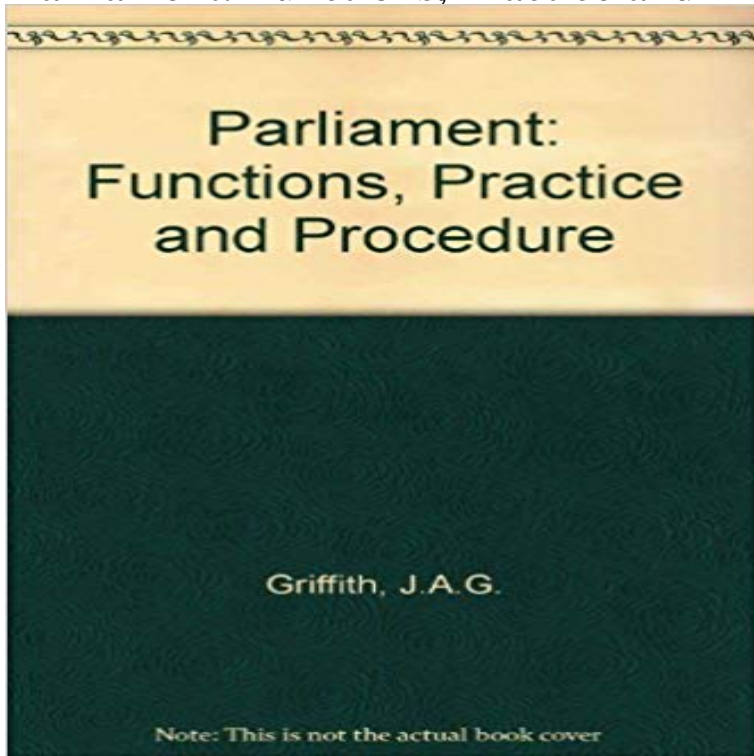


## Parliament: Functions, Practice and Procedure
