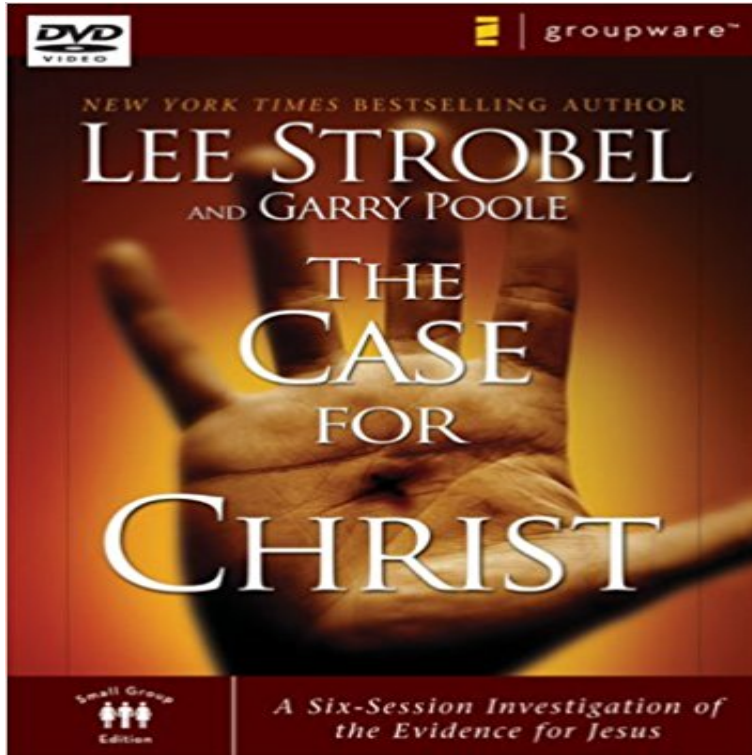


# The Case for Christ: A Six-Session Investigation of the Evidence for Jesus
