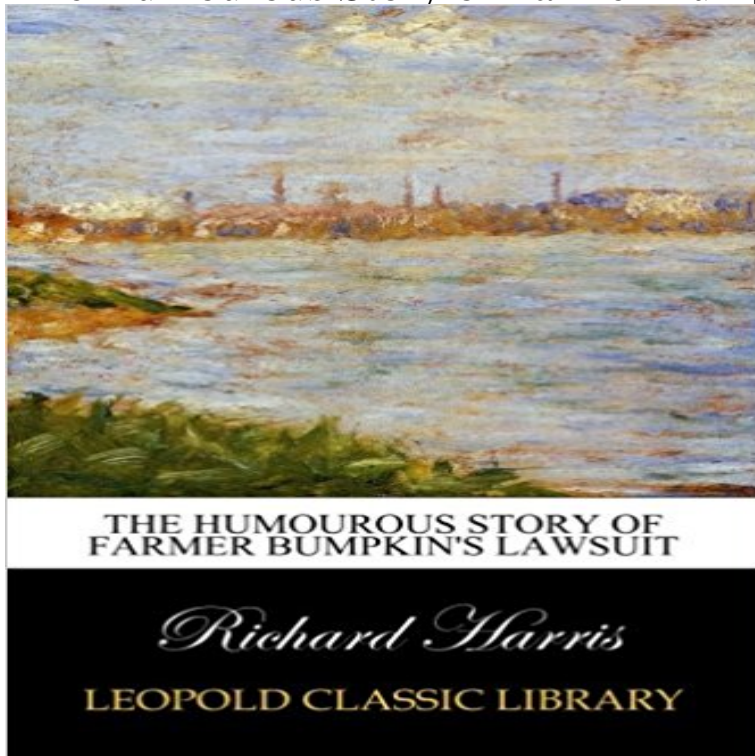


## The Humorous Story of Farmer Bumpkins Lawsuit
