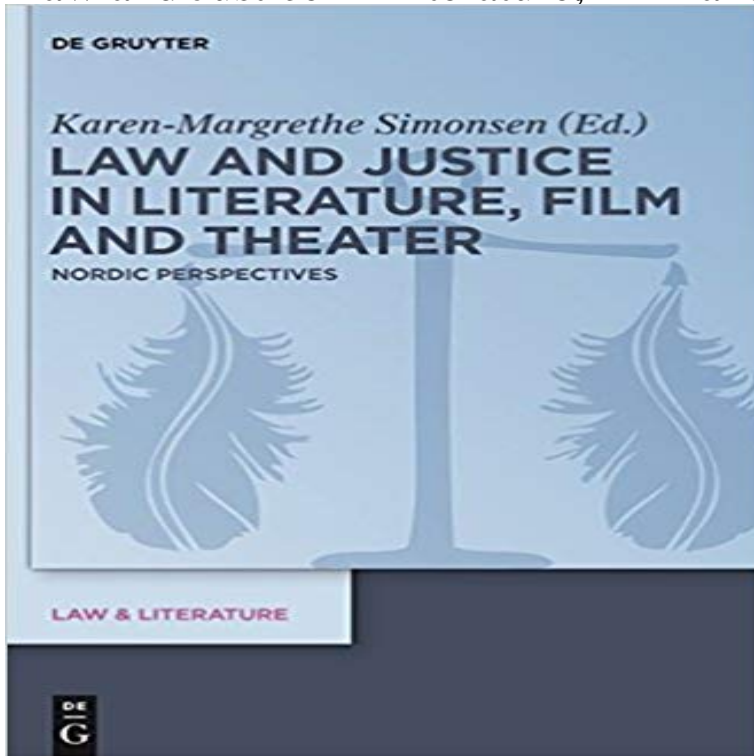


## Law and Justice in Literature, Film and Theater (Law & Literature)
