

Of the Conduct of the Understanding Lockes treatise Of the Conduct of the Understanding differs significantly in style and format from its predecessor, Some Thoughts Concerning Education. The Thoughts took form in a series of letters to Edward Clarke on the rearing of his children, and the work itself bears the characteristic marks of its origin: it is loosely drawn, often repetitive, and generally informal in tone. The Conduct, on the other hand, was initially conceived as an addendum to the Essay Concerning Human Understanding, and is in the character of that Essay, although at the same time more systematic and more abstruse. It can be read, as Mr. Garforth points out, both as an extension of the Essay, indicating the practical implications of the doctrines set forth there, and as a complement to the Thoughts, elaborating in particular those principles that apply to the cultivation of the intellect. Yet the cast of the Thoughts and the Conduct is essentially the same. Taken together, they stand squarely within the tradition of Elyots Governour, Brathwaits English Gentleman, and Chesterfields Letters, as courtesy books addressed to the problem of educating a ruling class. They assume, in the fashion of the genre, that the ideal training for leadership takes place, not in schools and universities, but within the family, and they sketch the principles for making that training noble, responsible, and effective. It was an attempt to influence Parliament to defeat a bill to lower the legal rate of interest from 6% to 4% - it was fixed by law at 5% on January 23rd 1692. of interest from an analysis of rent. He still regarded rent as the only surplus, and inquired how money, which was by nature barren, could have the same productive character as the soil, which did produce something useful. His conclusion was that just as the unequal distribution of land enabled those who had more than they could cultivate themselves to take a tenant from whom they obtained rent, so the unequal distribution of money enabled its owners to obtain a tenant for it from whom they could receive interest It was, however, Lockes emphasis on the medium of exchange function of money which was the starting-point for his further discussion. This was based on the quantity theory of moneyAgainst the prevailing mercantilist view that a low rate of interest would raise prices, Locke pointed out that prices were determined by the amount of money in circulation. This view was based on a supply and demand theory of priceLocke, in spite of occasional inconsistencies, held the view that changes in the amount of money were bound to affect prices.
