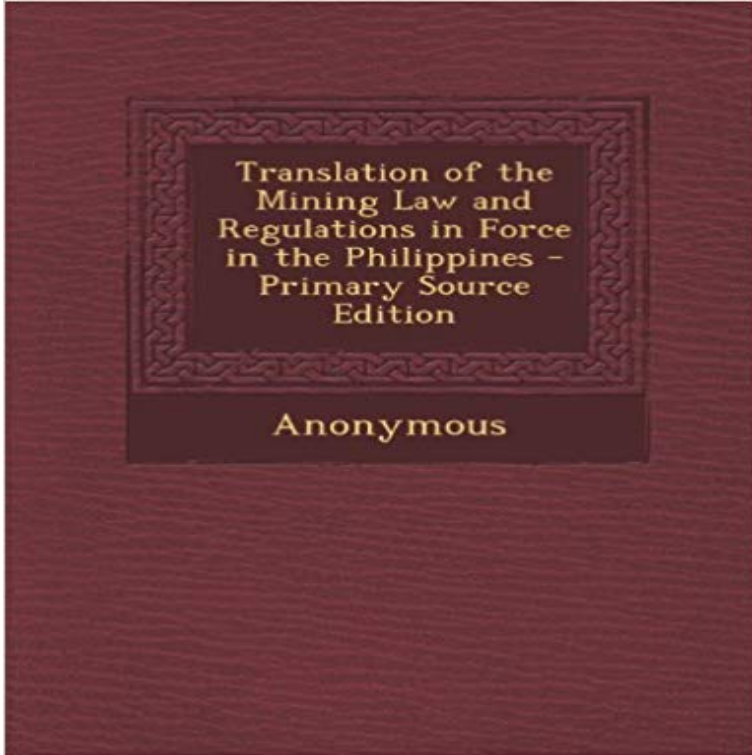


# Translation of the Mining Law and Regulations in Force in the Philippines - Primary Source Edition
